

Installation

Can be installed and operated in any orientation except permanently inverted

Batteries must not be suspended by their handles (where fitted)

Vent valves

Each cell is fitted with a low pressure release valve to allow gasses to escape and then reseal.

Gas Release

VRLA Batteries release hydrogen gas which can form explosive mixtures in air. Do not place inside a sealed container

Recycling
